

Whilst "liability cover" insurance can be purchased from a third party* to protect you from the cost of any liability in case of damage, it does not directly release you from the liability associated with hiring a **maui**, Britz or Mighty vehicle.

It is a mandatory requirement for you to accept liability directly with **maui**, Britz or Mighty. The daily vehicle rate includes standard liability. Please be aware that **without** the addition of the **Liability Reduction Option** or the

Inclusive Pack, you are liable for damage (as outlined in box 1 below) to your motorhome or any third party property on your hire. Any costs incurred will be calculated and recovered at the end of the hire, regardless of any independent cover you may have. You can seek reimbursement from the third party* from whom you purchased the liability cover insurance.

When you purchase the **Liability Reduction Option** or the **Inclusive Pack** in addition to your rental rate, you will have no liability.**

Please note: Per day rate will be capped at 50 days. A non-refundable administration fee applies to all Visa, MasterCard and American Express transactions. A customer's credit or debit card will be required for the purpose of the Credit Card Authority. The credit or debit card holder is jointly and severally liable for any damage to the rental vehicle.

New Zealand's statutory, no-fault Accident Compensation scheme covers everyone in New Zealand injured in an accident. Accordingly, **maui**/Britz/Mighty does not accept any liability for personal injuries sustained during the rental. Except where such loss or damage is caused by **maui**/Britz/Mighty's (or that of its employees) own negligence or breach of the **maui**, Britz or Mighty Rental Agreement Terms and Conditions, **maui**/Britz/Mighty does not accept liability for any loss or damage to any personal belongings or property of the Customer (or any person or entity related to the Customer). **maui**/Britz/Mighty strongly recommend that all people travelling in New Zealand take out personal travel insurance to cover injury or loss.

Where no liability** is present you are covered for single vehicle damage (except single vehicle rollover unless you purchase the Inclusive Pack), third party accident and cost for repair/replacement of unlimited windscreen and tyres. In New Zealand it is not compulsory for drivers to have private insurance on their own vehicles. Any breach of the exclusions will render all cover void.

All prices are gross rates and are quoted in New Zealand dollars.
